



## FINANCIAL RESPONSIBILITY

The South Valley Volleyball club teams provide a program which includes a schedule of practices from November 21, 2010 to June 30, 2011 with eight SCVA (1 Regional 2-day) tournaments beginning in January 2011 and ending in June 2011.

Collected fees cover the cost of player's uniform, Southern California Volleyball Association club, coaches and player registration packets, tournament registration, club insurance, facility use, equipment, coach's salaries, administrative expenses, club functions and other club related expenses. **Please note that any and all other tournament expenses outside of the eight listed SCVA tournaments (i.e. Las Vegas, Junior National Qualifiers, SCVA Summer Soiree, Volleyball Festival in Arizona, etc.) are extra costs to be incurred by the player should the team decide to participate.**

South Valley Volleyball Association functions on a shoestring budget with minimal operating costs. In order to avoid financial shortfalls each athlete and their family agrees to participate for the entire season and pay the full amount. To offset club expenses and in addition to the player's financial responsibilities, there will be a limited number of club fundraisers where each player and their family will be required to participate.

I understand that:

- I am, by accepting to join the South Valley Volleyball club team, financially responsible to pay the full amount of club fees regardless if my child participates in the entire program, only attends selected portions of the program, or quits the program. Additionally, I acknowledge that all payments are final and non-refundable.
- The club season runs from November 21, 2010 to June 30, 2011.
- If a player is not paid in full or is current in the payment plan, she will not be allowed to practice with the team or play in tournaments. Additionally, any payments over 10 days late will be charged an additional \$10.00. Repeated violations may warrant suspension or being dropped from the team and the spot on the team's roster filled by another player.
- Only in extreme medical related cases, where each situation will be considered on its own merits and, in the sole and exclusive judgment of South Valley Volleyball coaches will South Valley Volleyball provide a partial refund, a full refund, a interruption of payment, or a discontinuation of payment for the remainder of the season. There is, however, no guarantee that this will occur.

**I acknowledge that I have read and understand this Financial Responsibility Agreement Contract and will abide by the terms listed within and further understand that if South Valley Volleyball must take action for collection, costs and attorney's fees can be collected.**
